All students must comply with the rules and regulations that are specified in this contract. This contract is for all students attending the 2018 DECA Dorney Halloween Haunt Trip being held on Friday, October 26, 2018 from 4:45 pm until 1:00 am.

## All students must comply with the following rules:

- Don't push limits, keep in mind this is a school trip. School appropriate expectations apply!
- Only current MCTI students are permitted to attend the trip. Chaperones will be MCTI approved. Students MUST use the buddy-system and ALWAYS be with someone officially attending the field trip with MCTI.
- No illegal substances, alcohol and cigarettes included. No school banned items permitted.
- All students will be issued an MCTI logo'd item which <u>MUST be worn at all times</u> while off the bus at Dorney Park clearly visible to all MCTI chaperones.
- There will a 9:00 pm check in at Dorney Park's Coasters Drive-in. If you do not meet at the required time, consequences will be given for the rest of the trip.
