# THE SALVATION ARMY EAST STROUDSBURG IRENE CRAMER COMMUNITY SERVICE SCHOLARSHIP GUIDELINES AND APPLICATION INSTRUCTIONS

#### > Background:

Through the generosity of the Irene Cramer Trust Fund, The Salvation Army awards community service scholarships to eligible Monroe County students each year. The number of awards and the amount of each one varies from year to year based on available funding. In most years, The Salvation Army distributes about \$50,000 in total to deserving students.

If you're selected, you'll be notified by mid-April and invited to attend an award reception. Scholarship funds are sent directly to the recipient's postsecondary institution in one payment in late July or early August 2026. Please let us know if your student status or identification number changes so we can ensure the award is credited accurately to your student account.

#### > General Eligibility Requirements:

You may apply if you meet all of the following:

- You reside in Monroe County, PA.
- Your household income is below 300% of the 2025 Federal Poverty Guidelines (see page 5)
- You have a strong record of community service
- You are either a graduating high-school senior planning to enroll in an accredited postsecondary institution for the upcoming academic year or a student enrolled in an accredited college/university for the 2026-2027 academic year.

#### > Scholarship Application Instructions:

*All applications must be typed.* Read the form carefully and submit it with all required materials by the deadline. A fillable PDF application is available at: <a href="https://rebrand.ly/TSACramerScholarship26">https://rebrand.ly/TSACramerScholarship26</a>. *Handwritten*, incomplete, or late applications will not be considered.
